- Mesa I-HELP picks up 7 days a week at Paz De Cristo (424 W. Broadway rd.) in Mesa
- Each night a different area church hosts the guest of the I-HELP program

- Please arrive by 5:30pm (4:45pm on Mondays and Tuesdays)
- A meal and a place to sleep are provided

### Chandler I-HELP

- Chandler I-HELP picks up every SUNDAY, MONDAY, and TUESDAY at the Chandler Christian Community Center (345 S. California st.) in Chandler.
- Each night a different area church hosts the guest of the I-HELP program
- Men and women are welcome
- Please arrive by 4:00pm
- A meal and a place to sleep are provided

## East Valley Men's Center Fact Sheet

- WHAT:** A New Leaf's EVMC 94-bed shelter (76 shelter plus 18 transitional) provides comprehensive programs and strategies for each resident. Many of the men face challenges because of past substance abuse, criminal involvement, life changing events or simply a long life on the streets.
- WHO:** Residents are screened before enrollment and asked to be candid about the problems that resulted in their homelessness. Staff provides a supportive and structured environment to assure safety and respect. Residents are required to pursue employment and to save a majority of their income.
- HOW:** The Center provides life skills training, work assistance, AA and NA services, socialization skills, food, basic needs and shelter. Case Managers work individually with clients to set personal goals and address their barriers in becoming productive and contributing members of society.
- OBJECTIVES:**
- Increase residents' skills and income
  - Have residents achieve greater self-determination
  - Have residents obtain and remain in permanent housing
- WHEN:** EVMC opened in December 1998 and merged with A New Leaf in November 2006. A New Leaf's EVMC is funded by State, Federal and local East Valley City Governments, Mesa and Valley of the Sun United Way and a variety of charitable organizations. EVMC also receives support through fundraising, donations and volunteer services.

## East Valley Women's Shelter Fact Sheet

- WHAT:** A New Leaf's EVWS is an 8-bed, Emergency Shelter that provides services to help homeless women. EVWS residents can stay up to 120 days, during which time participants work with support staff to find permanent housing solutions.
- WHO:** Participants may stay for up to 120 days, during which time they work with EVWS staff and our Housing Navigator to meet immediate needs and break the pattern of homelessness. Participants are screened and once enrolled, and on site, complete an assessment and service plan that provides direction and meets their needs. Knowledgeable staff provide a supportive, yet structured environment to assure the safety of all participants.
- HOW:** The EVWS provides basic needs including; food, shelter and clothing. Through partnerships, including MesaCAN (Mesa Community Action Network), the shelter provides life skills training, work assistance, counseling and socialization skills. Participants work with support staff to set personal goals and address their barriers in becoming productive and contributing members of society.
- OBJECTIVES:**
- Increase participants life skills, employability and income
  - Have participants achieve greater self-determination and self-sufficiency
  - Have participants obtain and remain in permanent housing
- WHEN:** A New Leaf's EVWS opened the summer of 2013. EVWS is currently funded by DES with other potential funding opportunities available.
