

RESOLUTION NO. 2406

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE MUNICIPAL ELECTION OF FEBRUARY 21, 1984, DECLARING THE ELECTION OF ONE CANDIDATE TO THE OFFICE OF MAYOR, DECLARING THE ELECTION OF TWO CANDIDATES TO THE OFFICE OF COUNCILMAN, AND DECLARING THE NOMINATION OF TWO CANDIDATES FOR THE OFFICE OF COUNCILMAN IN THE CITY OF SCOTTSDALE RUNOFF ELECTION ON MARCH 27, 1984.

WHEREAS, the Municipal Election of the City of Scottsdale, Arizona, was held on February 21, 1984 pursuant to City Charter, for the purpose of electing a Mayor and three Councilmen of the City of Scottsdale; and

WHEREAS, the Council of the City of Scottsdale, Maricopa County, Arizona, have canvassed the returns of said election and find such returns to be as stated hereinbelow,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Scottsdale as follows:

1. The results of the canvass having been determined, the official canvass of the City of Scottsdale Municipal Election of February 21, 1984, is as follows:

3. Jim Bruner and Bill Walton, having received more than the number of votes constituting a majority of all ballots cast, were elected as Councilmen for four-year terms to commence on April 2, 1984.

4. Linda Brock, having received the next greatest number of votes cast in the Municipal Election, which number was less than the majority of all ballots cast, was nominated as a candidate for the remaining single office of Councilman for the Runoff Election on March 27, 1984, and Rene' Wendell, having

received the next greatest number of votes cast in the Municipal Election was also nominated as a candidate for said office of Councilman at said Runoff Election.
