

**RESOLUTION NO. 9972**

A RESOLUTION OF THE COUNCIL OF THE CITY OF SCOTTSDALE, ARIZONA, DECLARING THE OFFICIAL CANVASS OF VOTES CAST IN THE CITY OF SCOTTSDALE GENERAL ELECTION HELD NOVEMBER 4, 2014; AND DECLARING THE ELECTION OF THREE COUNCILMEMBERS.

WHEREAS, pursuant to Article 9, Section 1, of the Scottsdale City Charter, the City of Scottsdale held a General Election on November 4, 2014 for the purpose of electing three Councilmembers; and

WHEREAS, A.R.S. § 16-642 requires that the City Council canvass the returns of the election no later than twenty (20) days following the election; and

WHEREAS, the City Council, having canvassed the returns of the November 4, 2014 General Election, finds the returns to be as stated in this resolution;

NOW THEREFORE BE IT RESOLVED by the Council of the City of Scottsdale as follows:


1. The results of the election having been determined, the official canvass of the City of Scottsdale General Election held on November 4, 2014 is as follows:

Kathy Littlefield




