This Annual Progress Report is prepared by Hasan Mushtaq, Ph.D., P.E., CFM, PMP, Stormwater Engineering Manager and Floodplain Administrator/CRS Coordinator. After review and approval by the City's Emergency Manager, this report will be posted in the City's [Emergency Preparedness](#) public website.

In Maricopa County, most communities provide jurisdiction-specific information to be included in one single Multi-Jurisdictional Hazard Mitigation Plan (MJHMP), which was adopted by the Maricopa County Board of Supervisors on February 9, 2022, The Jurisdictional Summary for City of Scottsdale was adopted by the City of Scottsdale Council on January 31, 2022.

The City of Scottsdale partners with Maricopa County Department of Emergency Management (MCDEM) to develop a Multi-Jurisdictional Hazard Mitigation Plan every five years. Each year MCDEM does a cursory review of the plan and City of Scottsdale staff review the plan and update it informally. This Annual Progress Report was provided to Brian T. Cosson, CFM, State NFIP Coordinator, Arizona Department of Water Resources. 3. To promote hazard mitigation throughout the City of Scottsdale; and
4. To increase public awareness of hazards and risks that threaten the City of Scottsdale.

Of the 21 mitigation projects and actions in Scottsdale identified in the Maricopa County Multi-Jurisdictional Hazard Mitigation Plan, several projects have been completed and the remaining projects are ongoing. Details about these projects are contained in the attached Jurisdictional Summary for the City of Scottsdale. Overall implementation of the established objectives remains on schedule.

5. What are the recommendations for new projects or revised recommendations?

- a. Several new projects have been recommended since the update of the Jurisdictional Summary for the City of Scottsdale. These projects are, (a) Roosevelt Street Storm Drain Project, (b) 68th Street Storm Drain Project, (c) 82nd Street Storm Drain Project. There are several Local Drainage Mitigation projects awaiting future City funding for design and construction.
- b. The Flood Control District of Maricopa County has recently completed the 2024 Scottsdale Flood Response Plan (FRP). Currently, the plan is under consideration for adoption by Scottsdale City Council.
