Community Sustainability Plan: Summary of September 2024 Workshops

Introduction

The Scottsdale Community Sustainability Plan is an important part of the city's commitment to a more sustainable future. The City Council included adoption of a sustainability plan as part of the city's 2022 and 2024 organization strategic plans, and the plan was identified as part of the General Plan 2035 implementation.

Work on the plan began in June 2021, relying on input from the Scottsdale Environmental Advisory Commission (SEAC) and other community members. City Council feedback at five Work Study Sessions resulted in a sharp focus on the priorities, a push to develop baseline metrics and set numeric targets, and the need to include the costs and benefits of action.

The city has conducted a broad public input process to residents, boards and commissions and other stakeholders. Staff and subject matter experts have provided their guidance and ideas along the way. Two sets of community meetings were held in May and October 2022 in conjunction with a public questionnaire, to elicit feedback on an early draft and on overall priorities. As interim drafts were posted online and discussed at public meetings, additional input was gathered and incorporated.

Workshop Format

As a follow-up to City Council direction at the May 21, 2024, Regular Meeting, the city hosted two 90-minute interactive meetings on September 11 (SkySong) and September 16 (Florence Ely Nelson Park). The workshops were widely publicized on social media and via email and city newsletters. In total, almost 70 people attended.

After an introductory presentation on Scottsdale's efforts to be a more sustainable and resilient city, workshop participants had an opportunity to share ideas for enhancing the city's work. There were six stations for input – energy, water, waste, extreme heat, air quality and overall/general – with informational posters and subject matter experts to answer questions.

Input Received

Participants were asked to share their thoughts either on a comment card or sticky notes. More than 200 comments were received in response to the four questions below, ranging from one-word responses to full paragraphs.


- What should be continued or expanded?
- What else should we be doing?
- What should we not be doing? Or doing differently?
- Are there specific actions or elements that could be addressed?

Overall, attendees shared positive and extremely helpful feedback. There was a strong overlap with the strategies and actions included in the May 2024 draft plan. Support was especially high for planting more trees, diverting more waste, adding solar and conserving water. In some instances, comments suggested more ambitious action than currently included in the plan.

Few directly raised questions about the cost of strategies being discussed, while others suggested adding new incentives for specific strategies. There were some concerns over zoning and land use, often making connections between the impact of development and environmental impacts. Interestingly, some attendees requested additional requirements or mandates.

Participants embraced the community focus of the plan, and most suggestions focused on individual or business action to be more sustainable. Finally, several shared suggestions on how to improve future community meetings, including requests for more detailed dialogues on the plan topics.







Below are some themes that emerged from the discussions, reflecting when the same or similar ideas were shared by more than one attendee. All comments received are in Attachment 1, sorted by topic and by question.

Waste

- Significant support for actions that increase recycling and composting
- Interest in actions that would expand recycling at commercial properties, apartment complexes and short-term rentals
- Suggestions about using pricing and fines to achieve goals

Water

 Widespread support for existing programs, with suggestions on expanding or improving educational and rebate/incentive efforts

Extreme Heat

- Overwhelming support for adding more trees and shade, with some suggestions related to code requirements and enforcement
- Very detailed suggestions on how to implement strategies

Air Quality

- Mostly support for expanding electric vehicle charging infrastructure and adding electric vehicles to the city fleet
- Interest in expanding trolley, bus, bike and carpool usage and restricting the impacts of fireworks

Energy

- Significant support for increasing solar installations, including calls for adding solar to all city buildings and for requiring solar in new residential buildings
- Support and opposition for building codes adopted in 2023

- *This should be especially included in any new construction projects, but also in any renovation projects by developers.
- * Improve services that trim city trees -- to use best practices. Too many city trees are being over-pruned & cannot survive due to poor pruning by crews.
- (2) Explore ways to cool hard surfaces (concrete, road surfaces). Paint road surfaces w/reflective paints (City of Phoenix is experimenting w/this) (ASU is involved in designing products to be considered -- School of Sustainability).

- (4) Bring 'MaRTy" to Scottsdale! (from ASU) [drawing included] Hot spots need to be identified throughout the city -- where are these 'hots spots'? Identify locations & remediate with plantings, paint, misters, maybe develop structures to provide shade at hottest time of day. Maybe these structures can move & shift with sun direction change.
- (5) Playgrounds and vulnerable spaces for children. Infrared images show these hot spots. Materials used in play spaces need to be assessed -- slides, swings, etc. Important for childhood development: shade within playspaces, pollinator gardens, land contours (used for directional shade & privacy)

Too many people in too small a place is removing the exclusivity of Scottsdale and we will be no longer a town but a city with city issues

Too many people increase roads and the heat island concept. We need to spread out not compact & working against ourselves

Change the zoning for south Scottsdale to decrease the building of multifamily unit housing developments - (up arrow) the space from buildings and the street traffic created by population density decreases the appeal of Scottsdale for tourism

Slow down the new building in so Scottsdale. If not change the parameters. More shade and more undeveloped space further from street.

New building codes are restrictive and expensive. Please stop! Electric cars use energy. Why do we have less energy?

If there were a group devoted to this I would join it.

Make waste management and recycling more available to all: apartment complexes, offices, not only homeowners. 20 yrs ago Gently Strength (similar to sprouts now) used to have recycling bins in the parking lot. Anyone could drop off glass, cardboard, paper, clothing etc.

Extreme Heat: (6) Consider shade structures over canal paths. Work with APS and SRP -- share cost. (These areas are highly used by pedestrians & bicyclists.) (7) When creating new streets & intersections & new buildings create gathering spaces/green spaces with shade & seating connected with paths in neighborhoods. *Add shade trees (desert trees & shrubs) * Add seating, artwork (culture counsel) * Add water sources. Developers should be required to provide these respite locations in perimeters of their projects connecting to the existing neighborhoods.

Concentrate more on the educating the population from primary school level & follows it through their whole life

Organize volunteers squads to educate!

Increase designated neighborhood solar parking lots open to the public.
